

RESOLUTION NO. 08-013

A RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA BARBARA ESTABLISHING FEES FOR DANCE PERMIT APPLICATIONS, PERMIT RENEWALS, AND APPEALS

WHEREAS, the City Council adopted Ordinance No. 5445, entitled the DANCE PERMIT Ordinance, on January 29, 2008; and

WHEREAS, Section 5.20.190 of the Santa Barbara Municipal Code provides that fees will be set by resolution of the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SANTA BARBARA that the fees for applications, permits and appeals pursuant to Chapter 5.20 of the Santa Barbara Municipal Code are non-refundable and shall be as follows:

A. NEW DANCE PERMITS:

1. Initial application for dance permit

Night Club Permit		<u>\$1,200.00</u>
Live Entertainment Permit	<del>\$20.00</del>	<u>\$1,200.00</u>
Limited Dance Permit	<del>\$20.00</del>	<u>\$600.00</u>

2. Department of Justice (DOJ) fingerprint, per owner listed on application set by DOJ.

B. RENEWAL OF DANCE PERMIT:

1. Renewal application

Night Club Permit	<del>\$0.00</del>	<u>\$400.00</u>
Live Entertainment Permit	<del>\$0.00</del>	<u>\$200.00</u>
Limited Dance Permit (12 days a year)	<del>\$0.00</del>	<u>\$100.00</u>

C. PENALTIES FOR DELINQUENT RENEWALS:

1. 25% of renewal fee if paid within 30 days of permit expiration date.
2. 50% of renewal fee if paid between 31-60 days of permit expiration date.

D. APPEALS:

1. Appeal to Board of Fire and Police Commissioners \$100.00
2. Appeal to City Council \$150.00


