



NOTICE OF PUBLIC HEARING OF THE HISTORIC LANDMARKS COMMISSION TO PROPERTY OWNERS WITHIN 300 FEET OF A PROJECT

This notice has been mailed to you because it has been determined that your property is located within 300 feet of the project listed below. Tenants may receive this notice if required under State or local laws. The Historic Landmarks Commission (HLC) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **This structure is on the City's List of Potential Historic Resources and was determined to be eligible for City Landmark status: "Crointher Residence, Crocker Row." This project involves 2050 Garden Street and 314 E. Padre Street. Proposal to demolish an existing, detached 482 s.f. garage and construction of a new, detached 500 s.f. garage, a 96 s.f. workshop, and a 272 s.f. accessory structure. Also proposed is a new motor court and driveway, 570 s.f. pergola, and a completely new landscape plan including two benches, fountain and bird bath. Proposed alterations to the existing 3,522 s.f. two-story, single-family dwelling include extending the front porch, several door and window changes, and relocating a passage door in an existing garden wall. Zoning Modifications are requested for encroachment into the front and interior yard setbacks. The project will require a voluntary lot merger of this parcel with 314 E. Padre Street. Demolition of the existing single-family dwelling at 314 E. Padre was approved by the Historic Landmarks Commission under application MST2009-00277.**

Public comments will be allowed during review of the project by the HLC. The Historic Landmarks Commission is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are not within the HLC's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990.

This hearing is for design review only. The final land use decision will be made at another public hearing. You will receive another notice for that public hearing. The scope of this project may be modified under further review. If you have any questions, wish to review the plans, or wish to be placed on a mailing list for future agendas for this item, please contact HLC Staff at (805) 564-5470 between the hours of 8:30 a.m. to 4:30 p.m., Monday through Thursday, and every other Friday. Please check our website under City Calendar to verify closure dates.

If you, as an aggrieved party or applicant, disagree with the decision of the Historic Landmarks Commission regarding the outcome of this application, you may appeal the decision to the City Council. The appeal, accompanied by the appropriate filing fee per application, must be filed in the City Clerks Office within ten calendar days of the Historic Landmarks Commission decision.
