**Draft Updated Upper State Street Area Design Guidelines.** The draft guidelines constitute an update to the 1992 *Upper State Street Area Design Guidelines*. The guidelines are generally for public and City hearing body use in the formulation and review of development proposals. The updated guidelines are largely adapted from the *Upper State Street Study* adopted by City Council in May 2007. Staff will present the guidelines and recommends the Architectural Board of Review (ABR) and Planning Commission (PC) review and recommend the guidelines to the City Council for adoption.

You are invited to attend these hearings. Written comments are welcome and will be entered into the public record.
