On September 10, 2009, the Planning Commission approved a project that consisted of changes to the Montecito Country Club golf course, buildings and associated improvements (Planning Commission Resolution 035-09).

The current proposal is a Substantial Conformance Determination request to make changes to the approved project, including construction of a new 1,090 square-foot one-story employee lounge building located in the existing service yard adjacent to the Clubhouse; changes to the pool area and pool equipment building; changes to the eastern (upper) maintenance yard building, chemical storage building and comfort stations; and slight alterations to the parking lot design. Overall, the current revisions result in a reduction of 3,283 square feet of building area from the originally approved project, and a net decrease of 1,331 square feet

compared to existing development. No changes are proposed to membership levels or parking count.

The purpose of the hearing is to receive input from the Planning Commission and the public regarding the request. The Community Development Director will make the final determination as to whether or not the proposal is in substantial conformance with the approved project; therefore, the Planning Commission will not take a formal action on this item.
