(Proposal for two externally-illuminated wood blade signs of 7.75 square feet each, one non-illuminated vinyl window sign of 10 square feet, and one non-illuminated vinyl window sign of 6.25 square feet. The previously-approved wrought iron hanging brackets will be re-used. Two existing "Canary Hotel" painted wall signs will remain unaltered. New signage being requested is 31.75 square feet in addition to 23.5 square feet of existing signage. Total square footage on site will be 55.25 square feet. The linear building frontage is 75 feet. The allowable signage is 65 square feet.)
