(Proposal for 12 new non-illuminated ground signs to accompany newly proposed "Luke Pay Stations." Ten of the signs will have the ADA symbol, and all 12 will say "Pay Here." Total signage on site will be 58.50 square feet, distributed between four parking lots: 1) East Cabrillo Lot, 2) West Cabrillo Lot, 3) Garden Lot, and 4) Chase Palm Park Lot. The "Luke Pay Stations" are being reviewed by the Historic Landmarks Commission under a separate application, MST2015-00565. The project is located in the El Pueblo Viejo Landmark District.)
