The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: Proposal for a 192 square foot, upper-story addition and partial interior remodel to an existing 2,589 square foot split level single-family residence, including an attached two-car garage, located on a 47,916 square foot parcel in the Hillside Design District. The proposal also includes 50 cubic yards of grading, a new 105 linear foot, 4-foot tall retaining wall, a new patio and deck addition, replacement of all windows and doors, and replacement of the existing shake roof with a new shingle roof material. The proposed total of 2,589 square feet is 52% of the maximum guideline floor-to-lot area ratio (FAR).

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to SFDBSecretary@SantaBarbaraCA.gov.
