The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal for a total of 87 square feet of one-story additions, including 68 square feet to the existing residence, and 19 square feet to the existing garage, located on a 28,745 square foot lot in the Hillside Design District developed with an existing, 2,533 square foot, two-story, single family residence and detached, 467 square foot, two-car garage. The proposed addition will connect the existing residence to the existing detached garage. The proposal also includes replacing the existing roof with a new two-piece clay tile roof, a change to the roof form on the existing garage, door and window alterations, and the removal of a small area of paving to create a new landscape area. The proposed total of 3,087 square feet is 65% of the guideline floor-to-lot area ratio (FAR). The proposal includes Staff Hearing Officer review for a requested zoning modification.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O.
