The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues regarding the subject property below:

Project Description: **Proposal for two uncovered parking spaces at an existing two-story, 2,494 square-foot single-family residence with an 831 square-foot garage and storage area, and 586 square-foot detached accessory building. The proposal includes permitting the "as-built" conversion of the 831 square-foot garage and storage area into habitable space, the relocation of an air conditioning unit, removal of plumbing connections to an outdoor tub and shower, and a new on-demand water heater. The project includes interior work, including relocated laundry hookups, a new circular staircase and removal of food preparation amenities in the permitted accessory building. The proposed total of 3,911 square feet on a 2.19 acre lot in the Hillside Design District is 69% of the guideline maximum allowable floor-to-lot area ratio (FAR). This project will address violations in Enforcement Case ENF2015-00811 and Zoning Information Report ZIR2015-00457.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to SFDBSecretary@SantaBarbaraCA.gov.

This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review. Other methods to be informed of future scheduled hearings for a particular project or property include:

- a. Submit a request in writing to become an "Interested Party" for future notification purposes related to the development application so the City can mail or e-mail you future SFDB agendas when the particular project is scheduled on a future agenda. This type of notification is done as a courtesy and does not require 10 day advance notice.
- b. Join the City's SantaBarbaraCA.gov/MySB where sign up information can be found. This system allows you to manage subscriptions to City email lists that cover a wide range of City topics and services, including agendas sent for all Design Review meetings. Since all agendas would be sent, users of this service would need to check each agenda for their particular project of interest.

Appeals must be in writing and must be filed with the City Clerk at City Hall within 10 calendar days of the meeting at which the Board took action or rendered its decision.
